

MCKEAN COUNTY CONDITIONS FOR PROBATION AND PAROLE

Having been convicted of _____ you are this day placed on _____, under the supervision of _____, Adult Probation Officer of this court for a period of _____.

THE CONDITIONS OF YOUR SUPERVISION, WHICH YOU MUST OBEY, ARE AS FOLLOWS:

1. You are to report in person or in writing as instructed by your Probation Officer and will abide by any written instructions of your Probation Officer.
2. You will comply with all Federal, State, County, and Municipal Criminal Laws. Any violent, dangerous, or illegal conduct will be grounds for a Probation, Parole, or ARD revocation. You are to notify your Probation Officer within 72 hours of any arrest or investigation by law enforcement.
3. You will reside at _____, you will not change your residence without the prior permission of your Probation Officer. In addition, you will not absent yourself from McKean County (or your county of residence) for a period longer than 24 hours without the prior permission of your Probation Officer.
4. If you are not employed, you will make every effort to obtain and maintain employment. You will obtain permission from your Probation Officer prior to changing employment. If you lose your employment, you will notify your Probation Officer within 72 hours.
5. You will permit the search of your person, vehicle, and/or place of residence, where such place of residence is legally under your control.
6. You will submit to any recognized test to determine if you have been using or abusing drugs and/or alcohol. Random tests could consist of urine, breath, and/or blood screens. Refusal of a test will be considered a violation of this condition. The cost of this test will be charged to your court account.
 - A. At no time will you use or possess any illegal drug.
 - B. At no time will you use or possess any legal drugs without a valid prescription.
 - C. At no time will you possess any drug paraphernalia, which includes any object that aids the injecting, ingesting, inhaling, or otherwise introducing a controlled substance into the body; i.e. pipes, needles, syringes, etc.
7. You will pay costs, fines, restitution, administration, and supervision fee in the amount of \$ _____ + any summaries you may have. If there is **absolutely no way** you can pay in full within 30 days, you are to make payments of no less than \$ _____ per month. ***ALL COSTS MUST BE PAID IN FULL NO LATER THAN YOUR MAX DATE.***
8. If you are placed on Intensive Supervision, you will comply with all curfew requests set by your Probation Officer.
(CURFEW - _____ P.M.)
9. Even if you **do not have a no alcohol clause**, at any time that your **BAC is .10 or higher** it will be considered an "overt behavior" and could result in a revocation of your ARD/probation/parole status. Any refusal to submit to testing will also be considered a violation of these conditions.

If you believe that any of your rights have been violated as a result of your Probation/Parole/ARD Supervision, you may submit a timely complaint, in writing, to the Chief Adult Probation Officer, 500 West Main Street, Courthouse, Smethport, PA, 16749.

In the case of Probation and Parole Supervision, if the defendant violates any conditions as listed, he/she can be arrested and detained in the McKean County Jail until such a time he/she can be presented before the Court for Violations of Supervision. In the event the defendant violates any terms of the ARD Program, the District Attorney will Petition the Court to revoke ARD Supervision.

I have read or have had read to me the conditions governing my Probation/Parole/ARD supervision. I fully understand the meaning of the conditions and I am aware of the consequences should I violate them.
